



## CA Senate Bill 1383: Requirements for Food Recovery Services/Organizations

### What is SB 1383?

SB 1383 is a California state mandate to reduce organic waste destined for landfills by 75%, and to recover 20% of edible food that would otherwise be sent to landfills by 2025.

### Why is this law in place?

Food waste is the second largest contributor of organic matter in California landfills which produces methane gas, a known greenhouse gas pollutant. California has made a commitment to reduce greenhouse gas emissions and air pollution by implementing SB 1383.

### How and when does this affect my organization?

Agencies that voluntarily choose to participate in SB 1383 by establishing contracts or written agreements with Tier 1 and Tier 2 food donors must comply with SB 1383 or face fines and penalties. Below is a timeline of requirements you must meet.

### SB 1383 Timeline of Requirements

Year	Requirements	Actions you need to take
January 1, 2020	50% reduction in organic waste disposal	Identify Tier 1 and Tier 2 food donors
January 1, 2022	Regulations take effect and enforcement begins	Comply with recordkeeping and reporting for Tier 1 donors
January 1, 2024	Local governments take over enforcement	Comply with recordkeeping and reporting for Tier 2 donors
January 1, 2025	20% increase in edible food recovery	Comply with all SB 1383 requirements

## Are you a Food Recovery Service or Organization?

Food Recovery Service	Food Recovery Organization
A person or entity that collects and transports edible food from a commercial food donor to a food recovery organization or other entities.	An entity that engages in the collection or receipt of edible food from a commercial edible food donor and distributes that food to the public, either directly or through other entities. Including but not limited to: <ul style="list-style-type: none"><li>• A food bank</li><li>• A nonprofit charitable organization</li><li>• A nonprofit's charitable temporary food facility</li></ul>

## How does my organization become compliant?

### Step 1:

Establish a contract or written agreement with your food donors.

### Step 2:

Track the quantity of edible food (in pounds) collected from each commercial edible food donor per month.

### Step 3

#### (Food Recovery Service):

Track the quantity of excess edible food (in pounds) transported to each food recovery organization per month.

### Step 4

#### (Food Recovery Service):

Document the name, address, and contact information for each food recovery organization that the service transports edible food to for food recovery.
